## What are the changes in the revised Plan?

The following are the main changes in the revised Plan:

- structural revision of the Plan document;
- changes to the wording of some policies;
- incorporation of Local Green Space designations into the Plan text;
- revised references to the government's National Planning Policy Framework (NPPF), following publication of the revised NPPF on 23 July 2018.

**When:** The Consultation starts on **19 September 2018** and ends on **31 October 2018**.
